2022 City of Springfield Substantial Amendment and Annual Report

Public Notice is hereby given that the City of Springfield, Illinois, will make available for public review and comments its FY 2022 annual performance report for HUD funding, including its Community Development Block Grant (CDBG) and Home Investment Partnerships Grant (HOME). This report summarizes the City's use of federal funding to address its community development and affordable housing needs.

Public Notice is also given that the City of Springfield, Illinois, is proposing to substantially amend its 2023 Annual Action Plan to add a new proposed project to the budget.

The City is proposing to reprogram \$1.25 million for prior year allocations to infrastructure improvements associated with the redevelopment of the Poplar Place housing subdivision.
